1.1 Introduction

A draft version of this Environmental Impact Report (Draft EIR) was circulated for public review from January 7, 2009, to February 23, 2009. This chapter provides the names and addresses of persons, organizations, and public agencies that commented during this public review period.

In accordance with the California Environmental Quality Act (CEQA) Guidelines the Grossmont Union High School District (District) has evaluated the comments on environmental issues received from those agencies/parties and has prepared written responses to each pertinent comment relating to the adequacy of the environmental analysis contained within the Draft EIR. These responses are contained in Chapter 2, "Comments & Responses."

The agencies, organizations, and interested persons listed on the Responses to Comments Index (below) submitted comments on the Draft EIR during the public review period. Each comment submitted in writing is included, along with a written response where determined necessary. Each comment letter is identified with a letter in the upper right corner of the first page of the letter. The individual comments were given reference numbers, which appear in the right margin next to the bracketed comment. For example, Letter B has comment numbers B-1, B-2, B-3, etc.

In addition to the written responses contained in Chapter 2, and in response to comments received, certain revisions have been made to the Draft EIR. These revisions are presented in ~~strikeout~~/underline format in Chapter 3 and consist of changes to text that clarify information; only the pages that require revision are included therein. These changes do not constitute significant additional information that changes the outcome of the environmental analysis or necessitates recirculation of the document (CEQA Guidelines Section 15088.5). All such changes are presented in Chapter 3 and noted in the responses to comments.
